Why should you participate? We strongly believe that preventive healthcare will help us all live longer, happier lives. This confidential health assessment is centered on empowering you to take control of your health.

This event is provided to you for FREE. That's right, no cost to you! Plus, as an incentive, the Board of Trustees has approved up to a \$125 refund of the deductible for you and/or your spouse if you have the biometric screening performed by CHC at a Health Fair or a Labcorp facility.

What services are being offered?

- A health assessment and comprehensive blood test (biometric screening)- An appointment is required, and you must fast 10-12 hours before testing. You are only allowed to receive this service once every calendar year.
- Carotid artery (stroke) screening, peripheral artery disease screening, and abdominal aortic aneurysm screening- An appointment is required. You are only allowed to receive this service once every 12 months. If you received this service on October 26, 2024, you are not eligible for a screening until the October 25, 2025 event.
- Skin health screening- Appointments are recommended. You are only allowed to receive this service once every 12 months. If you received this service on October 26, 2024, you are not eligible for a screening until the October 25, 2025 event.

How to register.

Comprehensive Blood Test (Biometric Screening) You must fast 10-12 hours before testing. To register, go to app.chcw.com and enter the program code 6801Aut193 under the “New Participants” tab and select “Register” or if already registered, go to “Individual Login” and select “Log In”. Follow the prompts to verify your personal information, sign up for a screening, and complete the Health and Lifestyle Survey. More detailed instructions on how to register, additional information on the screening (free to you), along with additional testing options available for purchase will be included in a mailer coming to you shortly. If you need assistance, call 866-373-4242 to sign up for your screening over the phone.

For the most precise results, you must fast 10-12 hours before the comprehensive blood test (biometric screening). You cannot eat, but you may drink water, black coffee, or tea (no cream or sugar). If you are on prescription medication, please take your medication as instructed by your physician. If you are diabetic or hypoglycemic, consult your physician for fasting instructions. Be sure to drink plenty of water.

Carotid Artery (Stroke) Screening, Peripheral Artery Disease Screening, and Abdominal Aortic Aneurysm Screening

Skin Health Screening

SkinIO will be offering a skin health screening to detect different types of skin cancer. Appointments are recommended and can be made by scanning the QR code that will be included in a mailer coming to your home soon.

We assure you that this event is completely confidential and is administered by independent service providers, CHC Wellbeing, Health Gauge, and SkinIO. No one at the Fund Office or Union will have access to your personal health information.

We look forward to seeing you at one of the health fair events. There are limited appointments available, so please register ASAP as the spots will fill quickly. If you are unable to attend a Health Fair during the year, you can have the biometric screening performed by CHC through a Labcorp facility after first registering with CHC to access the paperwork you will need for your Labcorp appointment. In order to receive the \$125 deductible refund, the biometric screening must be performed by October 31, 2025 and you and/or your spouse must have each used \$125 of your deductible amount. If you used a lesser amount towards your deductible, for example \$50, you would receive a refund of only \$50.
